When you donate and shop at Frisko Resale, you are supporting your neighbors in crisis, living in our Frisco and Frisco ISD community.



2022 Board of Directors Responsibilities

The club will hold elections for the new officers in October / November with the new officers installed at the December Member Meeting. The voting will be handled by individual emails to each member with the ballot information included. The member will just need to mark the ballot in the email and hit reply. The results will be reviewed and any member that does not reply will be sent a second reminder. After a short period the results will be finalized by the nomination committee.

President

The President shall be the principal administrative officer of JOANT and shall, subject to the authority of the majority of the Board of Directors, be responsible for the management and direction of its business and affairs. The President shall appoint Chairpersons as necessary to run and oversee specific limited duration programs, shall preside at all meetings of the Board of Directors and of the members and shall perform all the duties normally incident to their office, and shall have such other powers and duties as may from time to time be prescribed by the Board of Directors.

Vice President

The Vice President shall serve as acting President in the absence of the President at any regular or called meeting of the Board of Directors or of the Members and shall perform such other duties as agreed with the President. The Vice President will be the lead in the planning of monthly meetings and other activities which may involve Jaguar or any other car clubs. The detailed planning of the monthly meetings may be assigned to one of the Directors to handle.

Treasurer

The Treasurer shall manage all the corporate funds and securities, and shall keep full and accurate accounts of receipts and disbursements in books belonging to JOANT, and shall deposit all moneys and other valuable effects in the name of and to the credit of JOANT in such depositories as may be designated by the Board of Directors. The Treasurer, no less than one time per year, shall be required to provide accurate financial statements of JOANT funds to the Board of Directors. Additionally, the Treasurer shall be responsible for the timely submission of accurate financial information to Federal, State and Local authorities as required by law. The Treasurer is responsible for the accurate and up-to-date listing of all members in good standing and shall coordinate with the Membership Chairperson to build the association membership.

2022 Board of Directors Responsibilities

Secretary

The Secretary shall attend all sessions of the Board of Directors Officer meetings and all meetings of the Members, and act as clerk thereof, and record all votes and the minutes of all proceedings in the book or files to be kept for that purpose, and shall perform like duties for any committee of the board of Directors when required. The Secretary shall cause to be given notice of all meetings of Members, Officers, and Directors, and shall perform such other duties as pertain to this office. The Secretary shall be responsible for the safe custody of the seal of JOANT and, when authorized by the Board of Directors, affix it to any instrument. The Secretary shall be responsible for the timely and accurate filings of corporate minutes to all Federal, State, and local entities as required by law. The Secretary will monitor the member attendance at monthly meetings and other events and send out follow-up emails or newsletters to the members summarizing club actions and activities.

Director One Year Term

The director serving the one year term will support the board as requested by the president and board members. This director will handle any additional tasks assigned by the board of directors and is intended to bring new ideas to the board. The person may be selected for a specific talent or knowledge base that the club needs help in.

Director Two Year Term

The director serving the two year term will support the board as requested by the president and board members. This director may be the chairperson or coordinator of the monthly membership meetings. This director may send out the Evites for all meetings and events. This director will ensure that any needed door prizes (wine or other items) are available at the meetings and any additional tasks assigned by the board of directors.

Director Three Year Term – Bryan Sanderford has one year left on his term of office so this position will not be voted on this year.

The director serving the three year term will support the board as requested by the president and board members. This director will be the chairperson or coordinator of special club events that will be ongoing or repeating events such as the Spring Fling, Slaloms, other clubs concours events and any additional tasks assigned by the board of directors.

Membership Chairman

This chairman will ensure the new members and existing members continue to feel welcomed in the club and become active members. This will include analyzing the attendance data from monthly meetings and other events to determine the type of events the membership supports and locations that draw the most members.
